1. That I have read and understood the terms and conditions and instructions contained in the prospectus and the school Diary of **SRIADVAIT GURUKUL HEIGHTS SCHOOL** Dated..... in which my Son/daughter has taken admission.
2. That I undertake to abide by all the terms and conditions contained the in the prospectus and school diary, unconditionally and without any reserve, all other instructions issued by the Principal or any concerned authority time to time during the period of my son's/daughter's tenure in this institution.
3. I give my consent to the school authorities for any emergency measures to be taken, in case of an emergency by way of accident/injury/medical emergency, etc. with the belief, that I will be informed as soon as possible. I shall not hold the school, responsible for any unexpected incident that may occur during any treatment, though necessary precautions are taken.
4. That my son/daughter will abide by all rules and regulations of the said school.

6. That from the time my son/daughter is admitted I shall be fully responsible and all matters relating to him/her will be dealt with the concerned authority solely by myself together with my wife or the person whom we may depute only in any case of extreme emergency or unwarranted occurrences of unexpected nature or for a specific case: but in all such instances the person whom we depute shall produce necessary documents of credibility of legal validity.
7. That I shall not ever demand any special, undue or extra-ordinary facility for my child alone other than what is already provided for all wards which I have personally seen and verified and of which I am fully satisfied at the time of taking admission.
8. I allow my child to visit the trips planned and organized by the school authorities and the school will not be held responsible for any mishap during the trips.
9. That my son/daughter shall remain regular in attendance and obedient to his/her teachers, and the school authority.
10. That my son/daughter will not bring to the school and its premises on any occasion during and after the school hours, mobile phone and any such gadgets or things forbidden by the school authority, which may affect the discipline of the institution.
11. That my ward will safeguard the school property and will uphold the good name of the school even when he/she is not in the school campus but is engaged in any activity outside, and even after leaving the school campus.
12. That my ward will not join or take membership in any movements, unions or parties, forbidden by the school.
13. That my ward will come to school in proper uniform and proper hair style approved by the school authority.
14. That I have thoroughly studied and am satisfied with the fee-structure of the school and I am willing to accept the pre-condition of annual enhancement of the same and am willing to pay the same and will not demand its refund once the fee is deposited.
